#### A Committee that hears no evil and sees no evil

The Committee on the <u>Terminally Ill Adults (End of Life) Bill</u> has completed hearing oral evidence on the Bill. Regrettably this evidence has been both one-sided and highly selective.

All invited witnesses from other jurisdictions were strong supporters of 'assisted dying' (which in most cases included euthanasia – a major problem with the ambiguous term 'assisted dying'). No witnesses reported any evidence of harm or abuse, but no critical voices had been invited.

What is equally striking is where these witnesses were from: seven from Australia, two from the United States, one from Spain, none from Canada, Belgium, the Netherlands or Switzerland. The preponderance of witnesses from Australia is remarkable for a number of reasons:

- In no Australian state is 'voluntary assisted dying' restricted to self-administration or to people with six months to live (as required by the Bill).
- Australia provides very little evidence as most states have only one or two years of data.
- The system in Victoria (which alone has five years of data) seems designed 'to find out nothing, investigate nothing and report nothing'.
- Successive legislation has seen a <u>rapid</u> erosion of the safeguards that were in place in Victoria (such as they were) and far higher rates of death (higher even than Canada).
- The latest law, in Australian Capital Territory, is like that in Canada in 2016 in that it is for conditions that are 'advanced' and 'expected to cause death' but without any timeframe.

By listening to witnesses from Australia where expansion has been pushed without evidence, and by not looking at evidence from Canada, which is where this expansion leads, the Committee has failed to give this Bill the scrutiny it requires.
